BONE MARROW SMEAR AND CYTOCHEMISTRY

BONE MARROW ASPIRATION, SMEAR

CLINICAL DETAILS

Bone marrow no. : BM/47/16

Clinical Details : Known case of fever-Low grade and irritability x 12 days. There is pallor, multiple lymph nodes, hepatosplenomegaly, bone skull swelling.

Multiple lytic lesions in skull bone. ? Neuroblastoma ? Lymphoma

CELLULARITY

Right sided bone marrow aspirate smears are cellular and show presence of abnormal cells

which are scattered singly and also present in small clusters. Abnormal cells are large in size having hyperchromatic pleomorphic nuclei and basophilic cytoplasm.

Normal hemopoetic elements are seen in the background.

Left sided Bone marrow aspirate and imprints are hemodilute. Occasional cluster and singly scattered large abnormal metastatic tumour cells are seen. Few normal hemopoetic cells are seen in the background.

DIAGNOSIS

Right sided Bone marrow aspirate smears are cellular and left sided smears are hemodilute; However, both show involvement by metastatic carcinoma.

Report on trephine biopsy will follow.

TREPINE BIOPSY

Surgical pathology no. S/1162/16

Specimen : 1) Left Trephine biopsy
2) Right Trephine biopsy

Gross :

1) Left Trephine biopsy - consists of single linear core measuring 1.0 cm. All processed in one block A.

2) Right Trephine biopsy - consists of single linear core measuring 1.2 cm. All processed in one block B.

Microscopic examination:

Section A: Left Trephine biopsy - Bone marrow biopsy shows ~ 5-6 marrow spaces and ~ 80% cellularity. There are occasional large abnormal cells with prominent nucleoli, scattered singly in marrow interstitium. Granulocytic series show all stages of maturation. There is mild prominence of eosinophils. Erythropoiesis is normoblastic. Megakaryocytes are adequate. There is no evidence of abnormal cell or granuloma.

Section B: Right Trephine biopsy - Bone marrow biopsy shows cartilage and ~ 5 marrow spaces which are hypercellular. In 4 out of 5 bone marrow spaces, there is diffuse interstitial infiltration by metastatic tumor cells, present in sheets and clusters in an eosinophilic fibrillary background. Normal hemopoietic elements are reduced.

Immunohistochemistry:
CD45 -Tumour cells are negative for LCA.
NSE - Positive
Synaptophysin - Positive
Chromogranin- Positive
CD99- Negative

Impression : Section A (left side) shows an occasional scattered metastatic tumour cells. Section B (right side) shows marrow involvement by metastatic carcinoma in 4 out of 5 bone marrow spaces.

Together with morphology and Immunohistochemistry, features are suggestive of metastatic bone marrow involvement by Neuroblastoma.

Note: IHC for CK, Desmin, Ki67, WT1, AFP are also recommended.
